Please note: Your monthly tuition Automatic Debit deduction may change due to added violation assessment fees, hot lunch, charge for extra hours, late pick-up, etc. You will be notified in advance of any extra assessment violations/fees.

Saint Patrick Preschool is a parish school, established for the children of the parish. The school also recognizes its responsibility of mission and service to the community at large, so other families are welcome to send their children to the school. Saint Patrick offers education, care, and supervision to preschool-aged children. By enrolling my child in the school, I agree to fulfill my responsibility to my child, to the school, and to the school community, as stated in this agreement. I understand that fulfillment of these responsibilities will determine my child's continued enrollment at Saint Patrick Preschool.

Please initial the following:

- I have read and understand the parent handbook
- I will support the preschool program and abide by its philosophy and objectives.
- I will keep my tuition payment current. I understand that payment is due on the first of each month. A \$25 late fee will be charged for late tuition that comes after the 5th of each month. A \$25 fee will also be charged for all returned checks.
- I understand that if the 1st falls on a Saturday or Sunday, my account will be debited on the previous Friday.
- I understand that the tuition payment is divided into 10 monthly installments and not by the number of days in each month. I am responsible to pay ALL 10 payments, beginning in August. I understand that if I start after August, I will be charged a late fee of ½ month tuition at the time of registration.
- I understand that a non-refundable fee of \$250.00 is due concurrently with my child's admission/tuition contract.
- I understand my monthly automatic tuition deduction may change due to violation assessment fees, hot lunch, charge for extra hours, late pick-up, etc.
- School day and part-time enrollments will be charged a fee of \$25.00 per hour (or any portion thereof) of hours exceeded.
- I understand that there are NO CREDITS for days missed due to illness or vacation.
- Community Care Licensing Agency has the authority to interview children and staff, and to inspect child or facility records without prior consent.
- Community Care Licensing has the right to observe the physical conditions, which would indicate abuse, neglect, or inappropriate placement and to have a licensed, medical professional physically examine the children.
- Any rate changes require a 30-day notice.
- New families are placed on a 6-month probationary status.
- I understand that my email address will be given to P.T.G. Class Reps for communication purposes.

Tuition Contract Options – 2020-2021

Please select the tuition type that is best for your family:

- A. Monthly Automatic Debit – from your checking or saving account. Ten (10) monthly payments beginning August and ending May. The debit will occur on the 1st of each month. **Please attach a voided check** to begin this process of deduction.
- B. Payment in Full – due by August 1st. Payment can be made by automatic Debit, credit, or check. **Please attach a voided check.** A convenience fee will be charged for credit card transactions.
- C. Pay by Credit Card – must be paid on-line on the 1st day of each month – a \$30.00 convenience fee will apply for each monthly transaction

As stated in the Saint Patrick Preschool Handbook, there is a \$25 late fee if payment is received after the 5th of the month. Parents delinquent in tuition payment will receive a warning at 30 days. At 60 days, the child will be dropped from the program at the discretion of the director.
